ADMISSION TO SESSIONS & FUNCTIONS

To attend sessions and functions other than the Industry Symposium, Exhibit Hall or Reverse Exhibit, company representatives are required to register for the conference.

BOOTH DESCRIPTION & FEE

Standard booth is 8'X10' and includes pipe and draping, identification sign, 6' skirted table, 2 chairs, and 2 luncheon tickets. Booths are assigned on a first come, first paid basis and allowing for specific exhibitor requests.

SET UP & TAKE DOWN

Exhibitors can access the exhibit area at 9:00 AM Friday morning. Exhibits must be set up by 11:00 AM. All exhibits must be removed immediately following the Exhibit Program.

PAYMENTS & CANCELLATIONS

The contract and space reservations are not binding until payment for the booth space is received by the Iowa Pharmacy Association. Written notice of cancelation must be received by the IPA office **before January 8, 2024**.

An administration fee of \$200 will be assessed. Exhibit cancelations **after January 8** will be charged the full exhibit fee unless space can be resold prior to the event. If the exhibit space is resold, a 50% refund will be awarded.
